- Considering : a. That in order to produce graduates who are superior and competitive nationally and internationally, it is deemed necessary to increase competence;
by participating in the Off Campus Learning through Innovation Class Program at the Beijing Genomics Institute (BGI) 2025;
- b. Whereas in the context of a form of cooperation between BGI and Institut Teknologi Del (IT Del) to improve IT Del human resources, an Assignment Decree is required;
- c. Whereas based on point a and b, it is deemed necessary to formalize this Matter through a rector's Decree.;
